2 Administrative Matters

At the outset, the Principal informed the House that the Higher Education Department has issued new e-admission modalities for the Degree Colleges for the session 2019-20. Out of the modalities, one most important modality is to open a new Bank Account in any Nationalised Bank in the name of SAMS Society by the concerned college. The other modality is that all the admission fees of every college would be centrally collected from the students through online and deposited in the SAMS Account of the Higher Education Department. Every College would get back their share after completion of the admission process.

The G.B. discussed the above modalities in depth and resolved that a new savings bank account be opened in the SBI, Chandi Chhak, Cuttack Branch in the name of "Principal, Christ College, Cuttack (SAMS, Society)" jointly operated by both Principal and Secretary for +3 Degree College. Another new account be opened in the same bank and under same nomenclature if it is required for Higher Secondary Schools as per the instruction of the Govt. It

was also resolved that a High Power delegation of the G.B. may be moved with a representation from the Secretary, G.B. and meet the Minister and Secretary of Higher Education Department to discuss regarding exemption of Christ College, Cuttack from the above modalities, since it is a Minority College and such type of modality would affect the financial status which would lead to utter administrative chaos.
